REPORTS

JACKSON ROAD AND WARD ROAD (LANCE HOYT)

Lance Hoyt, Public Works Director, presented the City's proposal on the Jackson Street Extension Improvements. The main purpose of the proposal was to ask the district to participate in the extension improvements which would create a road next to the high school stadium that would connect with Ward Road. In order to accomplish this project the City would need the Toppenish School District to provide fifteen additional feet of property. According the Mr. Hoyt, the Board donated an easement of 30 feet in 1979 to the City of Toppenish. The Board will meet during a special board meeting to discuss the proposal and take action.

ENERGY SOLUTIONS (APOLLO SOLUTIONS)

Mike Fuentes and Joseph Hojnacki, representative of Apollo Solutions Group (ASG) presented a proposal for a grant opportunity for energy efficient upgrades in our schools. Apollo Solutions Group is an energy services contractor who assesses, designs and implements infrastructure projects which are guaranteed to pay for them themselves through energy and operational savings. ASG guarantees the construction cost, energy and equipment/system performance. If these are not realized, Apollo will compensate TSD for the difference and perform any adjustments required to ensure that these systems are functioning at high-efficiency levels. The Board will meet during a special board meeting to discuss the proposal and take action.

SUPERINTENDENT'S REPORT

Annual Bus Inspection Results

Superintendent Cerna reported the Transportation Department received, once again, an outstanding bus inspection. Director Lommers suggested that the bus mechanics receive recognition as they are the ones responsible for the outstanding bus inspections.

Summer School Projects

Superintendent Cerna gave a brief report on the summer school construction projects. He said the engineering lab at the middle school should be completed before school is out. Two additional classrooms are being added to the Preschool. We are taking two of our portables back from the Yakama Nation Preschool to accommodate more of our students. Plans are also on the way to add eight additional classrooms to Valley View Elementary School in the future. Dave Andrews said in order to qualify for state funding for Valley View we need to solve the square footage issue at the middle school. The state looks at K-12 square footage, and the square footage at the middle school is so disorganized that we don't qualify for funding until we remodel and restructure the middle school. Once the remodel and restructure is completed at the middle school then we would qualify to add the additional classrooms at Valley View. school is currently going through a Study & Survey to see how much we qualify for state funding. Director Orozco asked if there were any plans for the tennis courts at the middle school. Superintendent Cerna said there have been some discussions but since the district doesn't receive state matching funds for athletics it has been on hold. Another project going on is the E-rate infrastructure at the middle school which has an anticipated completion date of August 6th.

Fresh Fruit & Vegetable Grant

Superintendent Cerna reported the elementary schools received the Fresh Fruit and Vegetables Grant again this year.

GEAR UP National Conference

Superintendent Cerna reported he attended the GEAR UP National Conference in San Francisco but didn't actually attend any of the conference sessions because he was participating in leadership training for superintendents. The training was enlightening; they were trained by some of the best in the country and had the opportunity to see what other districts are doing around the country. GEAR UP is covering all expenses related to the superintendent leadership institute.

Math Pilot at THS

Superintendent Cerna reported the Toppenish High School will be participating in an internet-based math pilot program called Mathematics Vision Project from Utah, and will be purchasing 230 IPads for all freshmen students.

Active Shooter Training

Superintendent Cerna reported the Board had an informational study session on Active Shooter Training. The facilitator provided a wealth of information to the Board. Mr. Cerna is currently working on developing a weapons policy.

He approached them and questioned if they had approval from the district to dig holes. Director Orozco recommended signs be posted to prevent this kind of activity. Superintendent Cerna said he had a conversation with the Maintenance Director this morning about placing signs at all our athletic fields.

ISTE TECHNOLOGY CONFERENCE

Barb Moses and Scott Kallenberger gave a brief report on the International Society for Technology Education annual conference and exposition. It was a great experience and one of the best conferences they have ever attended. There were over 20,000 attendees and about 1,400 vendors. They touched base with current vendors such as CDWG and also got several new ideas from possible new vendors. They had Ignite Sessions which were 5 minute presentations that advanced every 15 seconds with dynamic, engaging presenters sharing inspirational stories, great ideas, tool or practice. Mr. Kallenberger said he had a chance to speak with people from E-Rate and it looks like Priority 2 funding could potentially go away which could affect some of our wiring projects in the They are working on pumping more money into that program to help fund some of the lower income schools. Mr. Kallenberger said he should have more specifics in September. Ms. Moses said they had thirteen timeslots each day (Sunday-Wednesday) which covered educational technology programs, projects, lessons, ideas and concepts. They had featured recognized leaders and featured products and solutions. They also had several Bring Your Own Devise sessions which provided hands-on exploration of resources. Lastly, they had 42 learning stations held twice a day and it was amazing to see kids presenting their projects.
